## INFORMATION

Vendors will have 12 ft. x 12 ft. OUTDOOR area. Vendor spaces are issued on a first-come, first-served basis when your registration/payment is received. Vendors provide a tent, (must have a minimum of four weighted/ratchet-style tie-downs) tables, chairs, etc.

Sales tax is the responsibility of the vendor to collect and report.

Electricity is not available.

Generators, pets, or smoking are not allowed.

Food items will not be allowed unless they are professionally packaged or preserved, and they do not compete with what is already available on the farm.

Check-in/Set-up begins at 7:30 am. It would be best if you were finished with your set-up no later than 9:30 am. Takedown begins at 5 pm on Saturday and 4 pm on Sunday. PLEASE do not start takedown earlier.

You may or may not be able to park by your space. Vehicles must be parked where directed by the organizers of the show. We will have an area to park, so there is no interference with the customers to hinder their shopping experience.

You may leave your tent up during the evening but keep in mind that we are not responsible for theft or damage to your property.

Please provide a copy of your insurance along with your registration.

You are responsible for your cleanup, and nothing should remain when you leave the property.

Lunch order forms will be emailed to all participants 1-2 weeks before the event. Please print these and fill them out before you arrive for set up. Please get your order forms to Smokin' Blue BBQ by 9 am the day of the show. You will pay for your lunch at that time. If purchased, Smokin' Blue BBQ will deliver your lunch to your booth.

Payment is Non-Refundable; even due to inclement weather conditions/cancellation or shortening of the operating hours of the show if necessary for the safety of participants and/or guests.
